1. Govt. of NCT of Delhi has notified constitution of Police Complaint Authority vide order F.No.28/1/2017/HP-1/Estt./Partfile.635-641 dated 29.01.2018. The Police Complaint Authority shall consist of 1 Chairperson/Chairman and 3 members. The authority has mandated to enquire into allegations of serious misconduct against personnel of Delhi Police.
2. Applications are invited for filling up of 03 posts of Members of Police Complaints Authority for GNCT of Delhi in following categories:
 - A. Civil Society: A person of repute and stature with long experience of working in civil society organizations or working in related field.
 - B. Civil Service: A retired member of civil service (minimum of Scale of Secretary to GNCT of Delhi).
 - C. Police: A retired Police officer (minimum of scale of Joint Commissioner/ Inspector-General of Police or corresponding rank).
3. **Perks and remuneration:** The member shall be paid Rs. 2,11,300/- per month(fixed) (Level 15 of pay matrix) together with such allowances as admissible from time to time, provided further that if the whole time Member at the time of his appointment is in receipt of pension in respect of any previous service under the Government of India or under the Government of State, his salary, shall be reduced by the amount of that pension.
4. **Age limit and term of employment:** The term of Member of the Authority shall be three years, subject to upper age limit of 65 years.
