TERMS & CONDITIONS OF THE E- TENDER

1. Submission of /quotation shall amount to bidder's acceptance of the terms and conditions of the tender by the bidder.
2. Mode of payment would be subject to satisfactory completion of work and its verification.
3. Bidder shall quote the rates against this tender on a 'single responsibility' basis so that the Tender price covers contractor's all obligations and liabilities. The rates and prices quoted by the Bidder shall be inclusive of Taxes. The rate quoted shall be responsive and the same should be inclusive of all Statutory obligations.
4. Bidders will have to submit Bid Security (Earnest Money Deposit) for an amount of **Rs 4000/- (Rupees Four Thousand only)** in the form of an Account Payee Demand Draft from any Commercial bank in favour of DDO, D.C.F.(West), payable at Delhi. The EMD in original shall be submitted in the office of DCF(West), at Diary Dispatch counter on or before the closing date and time i.e. **10-03-2017 up to 11.00 AM**.
5. The bidder should be from Delhi and should be registered with VAT/WCA/Trade & Taxes department, GNCTD, and should quote their TIN no. allotted by Deptt. of Trade & Taxes, GNCTD, and PAN no. allotted by the Income Tax Deptt.
6. Deduction as per provision of DVAT and Income Tax and other applicable laws of land will be liable to be made from the bill of the bidders at the time of release of payment after satisfactory completion of work.
7. The Dy. Conservator of Forests (West) reserves the right to accept or reject any or cancel any or all the tenders without assigning any reason therefore.
8. The rates quoted by the tenderer shall remain valid for the entire period of contract and the Department shall not be responsible for payment any extra on account of escalation of costs during the said period.
9. The department shall not be responsible for payment of any compensation on account of any loss caused to the tenderer due to natural calamities or other supervening impossibilities.
10. The tenderer shall not construct any permanent structure at the site of work and shall have no right on the land or asset of the Government.
11. The tenderer shall abide by the provisions made under the Labour Laws/VAT and other relevant Statutes as applicable in execution of the work and shall be responsible for making good/ payment of compensation, if any, to any workman or material during execution of the contract.

In case of any dispute arising out of the execution of the terms & condition of this short term tender or part thereof, the decision of the Conservator of Forests, GNCT of Delhi shall be final and binding on both the parties.
