PUBLIC NOTICE

Pursuant to Hon'ble Supreme Court's order No. 333 in IA No. 316 in WP(C) No. 13029 /1985 & in connected IAs increased the cap on issue of permits to Three –Seater Auto Rickshaw (TSR) in the NCT of Delhi from 55,000 to 1 lakh, considering the request of the department, GNCT, Delhi and keeping in view of the increase in population in and around Delhi.

Therefore, Department of Transport, GNCT of Delhi has decided to issue ten thousands (10000) new TSR permits in first phase in accordance with the above order to residents of Delhi. The applicant may apply on prescribed form under rule 53 of the Delhi Motor Vehicles Rules, 1993. The eligibility criteria to obtain new TSR permits for plying in Delhi are as under:-

1. The applicant should purchase a new Auto Rickshaw (TSR) which should conform to mass emission standard of Bharat Stage – III and the same should also be from the list of Models approved by the Transport Department, GNCT of Delhi.
2. The owner of TSR should possess a valid TSR driving license and a Public Service Badge issued by the Transport Department, Govt. of NCT of Delhi.
3. The applicant should not possess any other TSR or Transport vehicle with permits.
4. The Auto Rickshaw permit would not be transferable for 5 years, except in case of death of permit holder as prescribed in section 82 of MV Act, 1988 and Rules framed thereunder. Thereafter the transfer to a person belonging to the same category can be considered. In case of legal heir of the deceased permit holder is minor OR not having valid driving license & PSV badge can hire a driver having valid Driving License and badge issued by Transport Department, Delhi.
5. Hire-purchase lease, Hypothecation deed shall be allowed for Nationalized Bank, Scheduled Banks and Non-Banking Financial Companies duly approved by RBI or any other competent authority notified by the Central Government.
6. The Electronic Fare Meter fitted in TSR should be GPS/GPRS integrated and duly approved, tested and sealed by the Controller, Weights & Measures Department, GNCT of Delhi. The Electronic Fare Meter manufactures/suppliers shall ensure that GPS/GPRS device integrated with Electronic fare meter is duly certified by Delhi Integrated Multi-Modal Transit System Ltd. (DIMITS), 1st floor, Maharana Pratap ISBT Building, Kashmere Gate, Delhi-110006 (web:www.dimts.in)
7. The new permits shall be issued maintaining a overall representation of SC-15%, ST-7.5%, OBC-27% and the rest others –all belonging to NCT of Delhi .All things being equal women applicants shall be given priority in the issue of permits in each category on a daily basis.

Further, in exercise of power vested in it under Section 74 for the Motor Vehicle Act, 1988 the State Transport Authority, Delhi hereby notifies its intent to issue new permits against the increased limit. The permit conditions for new permits in super-session of the Public Notice DC(ARU)/Tpt/2009/1248 dated 22.07.2010 for grant of permit are as under :-

- i) The permit holder shall charge fare from the passengers as approved by the Govt. as specified from time-to-time and a copy of fare table to be supplied by the Permit Issuing Authority shall be exhibited in the vehicle behind driver seat. The Electronic Fare Meter enabled with GPS/GPRS shall be kept in proper working condition.
- ii) The permit holder shall pay GPS/GPRS service charges at the rate and manner prescribed by STA.

- iii) The number of passengers shall not exceed 3 adults excluding driver.
- iv) The permit holder/driver shall not refuse to ply to any place within the NCT of Delhi.
- v) The driver shall wear the uniform in Grey colour as prescribed by the State Transport Authority (STA), Delhi. He/she shall display the Public Service Vehicle Badge on uniform on his/her left side of the chest.
- vi) The vehicle shall display the Helpline No. 42-400-400 of the Transport Department should be behind driver's seat. The name and address of the permit holder should be painted or affixed on the exterior of the body.
- vii) The vehicle shall be kept neat and clean at all times during the operation.
- viii) The vehicle must be equipped with the First Aid Box and Fire Fighting equipment as specified in Rules 66 of Delhi Motor Rules 1993. In respect of the Fire Fighting equipment, should be fitted inside the TSR near driver's seat.
- ix) The driver's identification/particulars along with his/her photograph to be displayed conspicuously inside the vehicle.
- x) The permit holder should adhere to the permit conditions of Auto Rickshaw, failing which he/she shall be liable for the suspension/cancellation of the permit.

The aforesaid permit conditions for issue of permits for new Autorickshaws shall come into force after 30 (thirty) days from the publication of this public notice in newspapers. Consequent to this, prospective applicants for new permits should apply in the prescribed manner with the relevant documents and the new vehicle to **MLO, Auto Rickshaw Unit, Burari, MLO, Suraj Mal Vihar, MLO, Sarai Kale Khan and MLO, Raja Garden** between **8.30 AM to 12.30 PM on any working day.**

This issues with the prior approval of competent authority.
