FILLING UP OF VACANT POST OF SENIOR RESIDENTS

(Radio-diagnosis and Forensic Medicine)

(Form submission will only be accepted only in online mode)

Applications are invited for filling up of **posts of SENIOR RESIDENTS** at Dr. BSA Hospital in Radio-diagnosis and Forensic Medicine. All candidates are informed to fill the application form online by using the link provided in this advertisement. **Selection will be purely on the merit basis based on interview.** The registered candidate should report in the office of Medical Director, Dr. BSA Hospital on the day of interview (as given below) between 9 am and 10 am for verification of admission ticket along with required documents. No entry/ verification will be allowed after 10:00 am.

GENERAL TERMS AND CONDITIONS

1. Number of the posts is provisional and subject to change according to vacancies without any notice.
2. Category wise panel of wait listed candidates will be prepared for filling up the posts of SR for vacancies likely to be created /arise in future.
3. Selected candidates may be posted under any institution under RDHS (North), if felt necessary in public interest.
4. Seats will be reserved for differently able candidates as per prevailing govt. rules.
5. In case, SC/OBC candidates are not available for the posts, the seats shall be filled up from general category candidates on Adhoc basis and vice versa.
6. Panel of wait listed candidates will be prepared for filling the post of SR for vacancies arising in future. The panel shall remain valid for 6 months or till fresh selection process is carried out, whichever is early.
7. In unforeseen eventuality of holiday being declared on the stipulated dates, the schedule shall get shifted to next working day or as decided by Medical Superintendent.
8. In case interview for all candidates is not completed on the scheduled date/duration, the interview shall be continued on following working day or fresh date will be announced for remaining candidates.
9. The decision of the Selection Board /Medical Director of Dr BSA Hospital regarding selection will be final and binding and no representation will be entertained in this regard.
10. The appointment and services will be governed under Residency Scheme, 1992, Government of India. Total duration of senior resident will be maximum of three years which will also include senior residency tenure done in other govt. /govt. funded institution. (Exception to above will be Residents selected under relaxed norms in accordance with circular no F121(26)/2010/H&FW/DSHFW/1996-2045 dated 10.06.2011 issued by H&FW Department, GNCTD, whereas, one additional year can be provided if the candidate is selected under relaxed norms). Appointment will be initially for a period of one year extendable up to maximum of three year on the basis of satisfactory Work & Conduct report from the concerned HOD and written request from the Doctor concerned.
11. The contract of appointment can be terminated by either party by giving a notice of one month in case of regular and seven days in case of adhoc without assigning any reason. However if termination is done under disciplinary grounds termination will be instant and no notice period will be served.

12. All appointment shall be subject to medical fitness and verification of certificate of educational qualification /age/caste/submission of valid DMC registration certificate etc
13. If any declaration /information furnished by the candidates are found false or any material/fact suppressed willfully, the candidature/appointment will be cancelled/terminated forthwith, due Administrative action/ legal action will be taken. Delhi Medical council will also be intimated for appropriate action.
14. No TA / DA shall be paid for participating in the Interview / written test / selection process.
15. The applicants are advised to fill the application form through the link given below very carefully and bring prefilled form on day of interview along with self attested photocopies of required documents. Original documents should also be brought for verification.

Important instructions regarding filling of form:-

1. The form can only be filled by clicking on the above mentioned link; the link will be valid from date of publication of this advt. till 18th November 2018 up to 12:30 PM only.
2. Immediately after submitting application candidate will receive an auto generated email. The mail contains the data entered by the candidate. Candidate should check the data, if any discrepancy is found the candidate is supposed to refill the form. Candidate is supposed to bring print out of this mail with photograph pasted on it. Instructions given in e-mail should be followed.
3. In case the candidate(s) do not receive the email, they should check the email provided by them. Even then problem persist or for any query, He/She should contact at residentbsah@gmail.com
4. Candidate is required to bring a printout as stated above along with photocopy and original of below mentioned documents on the day of interview.
5. Interview will be held as per the schedule given above. Candidates are required to report in Medical Director Office, Dr BSA Hospital between 9 to 10 am with required documents, No entry will be allowed after 10:00 am.
6. The result of selected candidates will be displayed on hospital website and notice board. No individual communication will be sent.
7. All the shortlisted candidates will be required to get their documents verified in the hospital before joining.
8. The selected candidates are supposed to join within one week from publication of result.
9. Suppression of information or wrong submission of information will be liable for appropriate administrative /legal action the same will also be intimated to Delhi Medical Council.

ELIGIBILITY & OTHER IMPORTANT INFORMATION FOR THE POST OF SENIOR RESIDENTS:

1. **Qualification:** MBBS with Post graduate degree/DNB/Diploma or equivalent as per Residency Scheme in concerned specialty from a recognized university/Institute. Must **not** have completed 03 years Senior Residency in any recognized institute including regular or adhoc basis.

2. **Age As On Date of Interview.** Shall be maximum of 37 years. The age is relaxable up to 05 years for SC& ST and 3 years for OBC candidates (OBC candidates belonging to Delhi only).
3. **Pay Scale:** Shall be in accordance with 7th CPC guidelines as adopted by GNCT of Delhi.
4. The candidate must be **registered (with MBBS and requisite postgraduate qualification) with Delhi medical council on or before the day of interview. The candidate should have valid DMC certificate.**
5. **Those who have already done Senior Residency in any of the Govt./ Govt aided Institution for three year are not eligible.**
6. **Total duration of Senior residency is three year irrespective of any institute. If candidate has done senior residency from any govt./ govt aided institute, but total duration done is less than three year, then he /she is eligible for rest of the tenure so as to complete three year of senior residency. However, under NO circumstances, total duration of senior residency will exceed three year, including tenure done elsewhere. However exception to this rule will be observed as stated below.**
7. In the specialties where there is perpetual shortage like in radiology, anesthesia, Forensic Medicine and General Medicine and fresh candidates are not available, candidates who have completed 03 years senior residency or candidates having experience of two years in that specialty (non pg) may also be allowed to appear in the interview. (They will be selected as per the relaxed eligibility criteria, instructions contained in circular no. F.No. 121/26/2010/H&FW/1996-2045 Dated 10/06/2011 of Health & Family Welfare, Delhi Govt.). Separate list will be prepared for fresh candidates and candidates short listed under relaxed criteria.
8. OBC candidates belonging to Delhi (Non creamy layer) will be considered for OBC seat. Candidate should have Delhi OBC (Non creamy) certificate issued within one year from date of interview.
9. The following documents are required in original with self attested photocopy for verification on the day of interview in the given order. Photocopy of documents to be arranged in following order:
 - a. Application/ email print out with passport size photograph affixed on it.
 - b. DMC registration (**MBBS and requisite postgraduate qualification**)
 - c. X class certificate (for date of birth)
 - d. Category: Caste certificate (in case of SC/ST/Non-creamy Delhi OBC, OBC certificate should be issued within one year from date of interview)
 - e. Post graduate degree/ DNB or Diploma
 - f. Attempt certificate
 - g. Graduation Degree (MBBS)
 - h. Aadhar card/ Voter ID/ Passport
 - i. Experience certificate if applicable
 - j. **Publications (indexed journal only)**
10. The candidates should report for the interview on **stipulated date, between 9.00 am and 10 am** in the Office of Medical Director, Dr. BSA Hospital, Sector –VI, Rohini, Delhi -110085 along with printout of the application form as stated above along with photocopy and original of the documents mentioned above.
11. **The result shall be displayed at the web site of the hospital and notice board as early as possible. Selected candidates would be required to join within stipulated time (one week).**
12. **All candidates are advised to see the notice board /Official website of the hospital for list of shortlisted / selected candidates regularly. No letter or personal information shall be given.**
