ELIGIBILITY

For SR: MBBS with P.G. Degree/Diploma in the concerned specialty from a Recognized University/Institution and should be Registered with Delhi Medical Council. .

In case of non-availability of SR with in the prescribed age limit mentioned below, the age limit may be upto 40 years.

In case of non availability of PG candidates, non PG. MBBS Candidates with two years experience, out of which one year should be in specialty, may be considered.

EMOLUMENTS

For SR, Rs. 74000/- + usual allowance as admissible under the rules .

AGE LIMIT: For SR, below 35 years, as on 31st December, 2016. Relaxable for SC/ST by 05 years and for OBC by 03 years (OBC candidates are required to submit their caste certificate issued by the Competent Authority of Govt. of NCT of Delhi).
