Sub: Revised price structure of country liquor for the year 2013-14

In supersession of earlier price structure of country liquor issued for the year 2013-14 circulated vide letter number F.1(66)/EX/CL/13-14/1495-1504 dated 18.5.2013, I am directed to inform you that Govt. of NCT of Delhi has revised the retail price and retail margin of country liquor. The revised price shall be effective from 01.07.2014. Therefore, the revised price structure for the approved L-3 licensees is as under:

Further, as per clause 16(c) of Terms & Conditions for the tender for the year 2013-14, local transportation charges @ 2.50 per case shall be charged by L-3 Licensee from the L-8 Licensee in addition to the wholesale price.

The corporations are further directed to submit the closing stock position as on 30.06.2014 available with L-8 vends and the differential amount on that stock may be deposited in Excise as well as VAT. The corporations are further directed to do the following:

1. To change MRP on bottles by affixing stickers.
2. To display the new MRP in front of all vends in Hindi & English.
