Educational & other qualification required for direct recruitment	Essential: i) Master's Degree in relevant stream of Humanities & Science with first class or equivalent, at Bachelor's or Master's Level from any recognised Indian University. ii) Besides fulfilling the above qualification, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET. iii) Notwithstanding anything contained in sub-clauses (i) and (ii) to this clause; a candidate, who has a Ph.D. Degree awarded before 2009, or has been awarded a Ph.D Degree after 2009 in accordance with the UGC (Minimum standards and procedure for Award of Ph.D Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment. If a class/division is not awarded, minimum of 60% marks in aggregate shall be considered equivalent to first class /division. If a Grade point system is adopted, the CGPA will be converted to equivalent marks as below :-
