One post of Senior Resident will be reserved for Person with disability candidate as per reservation Policy of Govt of India under section 33 of the Person with disabilities Act 1995.

2. ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENTS -

Qualification:-

- 1.** (1) MBBS with Post Graduate Degree/ DNB/ Diploma or equivalent as per residency scheme in concerned specialty from a recognized University/ Institution.
(2). In the condition, if candidates having P.G. degree/DNB/Diploma are not available, those without P.G. qualification but having 02 years experience in concerned specialty may be considered on adhoc basis till the regular candidate joins.
- 2. Age :-** Below 37 years, **On Date of Interview**, shall be for General candidates. 5 years relaxation for SC/ST. Person with disabilities shall be given relaxation as per Govt. of india rules.
- 3. Pay:-** Basic of RS. 67700/- in pay Matrix 11 of 7th CPC with other allowances as admissible per month.
- 4.** The candidate must have completed internship.
- 5.** Must be registered with Delhi Medical Council.

6. Appointment will be initially for a period of 1 year extendable up to maximum of three year on the basis of satisfactory work & conduct report from the concerned HOD and written request from the doctor concerned.
7. Appointment will be subject to medical fitness and verification of certificate of educational qualification/age/caste/DMC registration and internship completion certificate etc.
8. Candidate must not have completed three year senior residency from any Govt.Hospital.(*)

(*)**Further in case of** non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of relaxation of provision as per circular No. F.No. 121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi with the following relaxation.

1. Upper age limit for eligibility under the relaxation will be 40 years.
2. In the Specialities, where no fresh candidates are available, candidates, who have completed 3 years of Sr. Residency may also be allowed to appear in the interview.
3. Separate merit list would be prepared for the candidates who have completed their residency of 3 years as SR.
4. Firstly the list containing name of fresh candidates would be exhausted for appointment as SR and the second would be used only after that.
5. Further, all senior Resident appointment from second list will be for one year only (on adhoc basis). It would not be renewable after one year. **Senior Resident may be assigned duties in Emergency Department as & when required in case of any exigency.**

9. CONDITION FOR RECRUITMENT –

- A. All the eligible candidates should report in the office of the undersigned at 9.30 A.M.[Time for enrollment from 9.30 A.M. to 11.30 A.M. only] on the day of interview.
- B For candidates applying for OBC category, the certificate must be issued by the competent authority of Govt. of NCT of Delhi. Persons with disabilities shall be given relaxation as per rule.
- C The number of vacancies may vary.
- D No TA/DA will be given for appearing in the interview.
- E Candidate must submit their Bio-Data with attested photo copy of certificates and original documents should be shown at the time of interview.
- F Candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the advertisement before appearing in the interview.
- G Other services conditions will be applicable as per service condition prescribed from time to time by the Govt. of NCT of Delhi.
- H **Candidates who are presently working on adhoc basis In this hospital will have to apply afresh in response to this advertisement.**
- I The decision of the selection board regarding selection will be final and binding and no representation will be entertained in this regard.
- J The services of S.R. will be Governed by Residency Scheme of Govt of India/ Civil Services (Temporary Rules.) .
- K. All Candidates are exempted from payment of Fee.

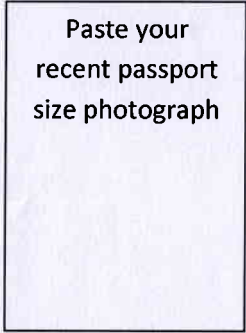
