## **ORDER**

In view of severe air pollution situation caused by dust in Delhi, directions issued by Hon'ble Lt. Governor in the high level meeting on 14.06.2018 with all the stakeholder Departments/Agencies, directions of EPCA, recommendations of task force constituted under CPCB and provisions of Graded Response Plan for Delhi & NCR, all concerned Departments/Agencies are directed to ensure compliance of following decisions in additions to the provisions of Graded Response Plan already enforced;

- Municipal Corporations, DPCC and all construction agencies are directed to enforce directions issued by DPCC vide order F. No. DPCC/PA to MS/2018/89-109 dated 14.06.2018 to stop all Civil Engineering construction in Delhi
- 2. Municipal Corporations and PWD are directed to intensify mechanical road sweepings and sprinkling.
- 3. Municipal Corporations, DDA and SDMs are directed to strictly enforce prohibition on open burning of garbage, plastics and leaves etc..
- 4. Municipal Corporations, DPCC and PWD are directed to impose fine/penalties on all road construction agencies/contractors, where there are inadequate dust control measures.

All Departments/Agencies are directed to issue necessary notifications/orders for implementation of above directions.
