Sub: Nomination of Officers and Staff for Third Training Programme on "Rights of Persons with Disabilities Act 2016" and Reservation at Directorate of Training, UTCS on 19.01.2018.

Sir/Madam,

You may recall that in light of my interactions with the concerned officers appearing on behalf of various Departments/ Organisations during the hearings of complaints of persons with disabilities, it was proposed to the Chief Secretary that a series of capacity building training programmes on Rights of Persons with Disabilities Act, 2016 (RPWD Act) and related issues should be organised for functionaries of GNCTD and Local Authorities so as to cover most of the officers and staff. In pursuance of that decision, two training programmes on RPWD Act and reservation of vacancies for persons with disabilities were organised by this office at UTCS on 07.07.2017 and 09.11.2017.

2. In their feedback, the participants of the two training programmes have highly appreciated the training and have suggested that all the officers and the staff in the Establishments of Govt of NCT of Delhi and local authorities should be trained and the training should be for longer duration of 2-3 days. UTCS vide letter dated 18.12.2017 has scheduled one-day training programme on "Rights and Welfare of Persons with Disabilities" on 19.01.2018 and has invited nominations. Keeping in view the need for capacity building, it is proposed to organise the third training programme on **RPWD Act, 2016 and reservation for Persons with disabilities at UTCS Institutional Area, Vishwas Nagar, East Arjun Nagar, Shahdara, Delhi-110032 from 10.00 am to 4.30 pm on 19.01.2018**

3. It is requested that Officers and the staff particularly dealing with service matters (recruitment, promotion, transfer/posting, maintenance of reservation rosters, etc.), admission in educational institutions and Grievance Redressal Officer, if appointed under Section 23 of the RPWD Act in your Department/ Establishment may be nominated for the above training. This

will help them acquire enhanced professional skills, better delivery of services and in promoting a more inclusive work environment in Government offices.
