**Qualification:** MBBS with P.G. Degree/Diploma/DNB in the concerned specialty from a recognized University / Institution and P.G. Degree of Oral Surgery (Dental) from recognized Institute / University and should have a valid registration with Delhi Medical / Dental Council. Must have not completed 03 years Senior Residency in any recognized institution including regular & adhoc period.

**Note:** - In case of non-availability of candidate with PG Degree/Diploma, candidate with two years experience during PG Degree/Diploma in the respective specialty will be considered.

**Pay scale:** PB-3 of Rs. 15600-39100+ Grade Pay Rs. 6600 plus allowances as admissible under the rules.

**Age:** 33 years for Gen, 38 years for SC/ST and 36 years for OBC candidates on the closing date of submission of application.

- (i) Upper age limit for eligibility under relaxation will be 40 years.
- (ii) In the specialties where there is perpetual shortage like anesthesia and radiology etc. or in specialties where no fresh candidates are available, candidates who have completed 3 years of Sr. Residency may also be allowed to appear in the interview.
- (iii) Separate merit lists for fresh candidates and for others (those who have completed 3 years of Sr. Residency already) would be prepared.
- (iv) Firstly, the list containing the names of fresh candidates would be exhausted for appointment as Senior Residents and the second list would be used only after that.

**Tenure:** All Senior Residents appointment will be for 89 days only initially.

**Qualification:** MBBS degree from a recognized University. Valid registration with Delhi Medical Council. Must not have completed one year Junior Residency in any recognized institution including regular & adhoc period. Candidates who have completed internship earlier than 16/03/2013 are not eligible.

**Pay scale:** PB-3 of Rs. 15600-39100+ Grade Pay Rs.5400 plus allowances as admissible under the rules.

**Age:** 30 years for Gen, 35 years for SC/ST and 33 years for OBC candidates on the closing date of submission of application.

**Note:** - Further, in case of non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of the relaxation of provision circulated as per circular No.F.121/26/2010/H&FW/1996-2045 dated 10/6/2011 of Deptt. of H&FW, GNCT of Delhi with the following relaxations:-

- (i) Upper age limit for eligibility under relaxation will be 40 years.
- (ii) Post Graduate doctors who are interested to serve as Junior Residents will be allowed to join as Jr. Residents if fresh graduates are not available.
- (iii) Junior Residents who have completed one year of JRship may be allowed to again appear for interview for selection and will be offered residency only if no fresh Junior Residents are available. There would be no extension for any Junior Resident beyond one year of appointment under relaxed provisions.

**Tenure:** All Junior Residents appointment will be for 89 days only initially.
