**a) ELIGIBILITY:** - MBBS with P.G Degree or Diploma in the concerned specialty from a Recognised University/Institution and should be Registered with Delhi Medical Council.

**1. Eligibility of Senior Resident for Cardiology :-  
MD/DNB in Medicine/Pediatric/Pulmonary Medicine.**

NOTE: The selected candidates should have to produce DMC Certificate with P.G. qualifications before joining. Those candidates who have applied for registration to DMC shall not be allowed to join merely on production of DMC fee receipt.

**b) PAY:** - Rs 67700/- plus usual allowances as admissible under the rules.

**c) AGE LIMIT:** - Below 40 Years as on **20 February 2018 for post graduate candidates.** Relaxable for SC/ST by 05 Years and for OBC by 03 years (OBC candidates are required to submit their caste certificate issued by the Competent Authority of Govt. of NCT of Delhi.)

**d) FEES PAYABLE:-** Rs.300/-(Non-Refundable) in the form of Demand Draft only issued by a nationalized bank in favour of **MEDICAL SUPERINTENDENT, G.B. PANT HOSPITAL**, payable at New Delhi. The candidate may also deposit the Fee (in cash) to the Cashier at Accounts Branch of the Institute.

**CONDITIONS OF RECRUITMENT (Senior Resident):-**

1. The tenure of **Senior Resident** is for 03 years including any service rendered as Senior Resident earlier on adhoc/regular basis in any Institution. The appointment will be initially for a period of **one** Year, which could be extended for a period of another two years on annual basis, subject to the satisfactory work and conduct report from the concerned Head of the Department.
2. Other service conditions as prescribed from time to time by the Institute will be applicable.
3. Inter Hospital/Inter Institutional transfer shall not be permitted.
4. The candidates who are already in Govt. service should submit NOC.
5. The candidates who are working on adhoc basis (including those on extension) in GIPMER shall have to apply afresh for Senior Residency.
6. The candidates should be registered with Delhi Medical Council.
7. Their service will be governed by residency scheme.
8. Where no fresh candidates are available, candidates who have completed three years residency but are willing to serve as Senior Resident may also be allowed to appear in the interview.
  - (i) Separate merit lists for fresh candidates and for others (those who have completed 03 years of residency) would be prepared.
  - (ii) Firstly, the list containing names of fresh candidates would be exhausted for appointment as senior residents and the second list would be used only after that.
  - (iii) Further, all Senior Residents appointments from second list will be for one year only in adhoc basis. It would not be renewable after one year.
9. The candidates should bring all original documents along with their attested photocopies on the scheduled date of Interview.
- 10. No correspondence or personal enquiries shall be entertained.**
11. No TA/DA will be paid for the Interview.

**JURISDICTION OF DISPUTE: -** In case of any legal dispute the jurisdiction of court will be Delhi/New Delhi only.
