Qualification:- MBBS/BDS from recognized university/institution and must possess valid Registration Certificate from Delhi Medical Council for MBBS candidates and from Dental Council for BDS candidates. The candidate having completed compulsory rotatory internship after 01/8/2010 shall be shall be given preference.

Pay Scale:- PB-3 of Rs.15600-39100 + Rs 5400 as Grade pay plus allowances as admissible under the rules.

Age:- 30 yrs for General, 5 yrs relaxable for SC/ST and 3 Yr for OBC candidates (belonging to Delhi) on the closing date of submission of application.

Tenure:- The maximum tenure of Junior Residents (MBBS) is for a period of one year only including any service rendered as junior resident earlier on ad-hoc /regular basis in any recognized institution. - 5. Post graduate doctors who are interested to serve as junior residents will be allowed to join as junior residents.
- 6. All appointment of residents from the second list will be for 1 yr only; it would not be renewable after one year.

Other conditions and requirements:-

- 1. For appointment against posts reserved for SC/ST/OBC only candidates having the OBC certificate issued by the competent authority of GNCT of Delhi shall be eligible. - 2. All SR/JR already working on Ad-hoc basis in Dr. Hedgewar Arogya Sansthan may need to apply and appear in the interview afresh.
- 3. The candidates who are already in govt. service should submit an NOC from the employer.
- 4. In case of non availability of SC/ST/OBC Candidates, the post shall be filled on ad-hoc basis from the other categories.
