In case of research experience, books/research paper publications/IPR/Patents record shall be required as deemed fit by the expert members of the Selection Committee.

To exercise financial powers invested in his position with honestly, transparency, objectivity and judiciousness, in the interest of the institute and all other stake holders.

To promote, create and nurture support systems for publication of research papers and books by the teaching faculty and to nurture a congenial atmosphere for harmony amongst the teachers, the students and all other the stake holders with a focus on service to the nation and humanity.
