

**TERMS & CONDITIONS FOR FIXATION OF RESERVE PRICE OF
CONFISCATED VEHICLES**

1. The successful bidder shall fix the reserve price of vehicles in list provided to them within 30 days of receiving the list.
2. The proforma for quotation should be clearly filled in ink legibly or typed. The bidder should quote the number, rates and amount quoted by him/them in figures and as well in words.
3. The successful bidder shall deposit a performance security of 5% of the amount of contract in the form Pay Order/Bank Draft/Fixed Deposit Receipt in favour of Commissioner (Excise), Government of NCT of Delhi.
4. The performance security will be liable to be forfeited if the bidder withdraws or amends, impairs or derogates from the quotation in any respect within the period of validity of the quotation.
5. The Department reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to award contract without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds of the Department's action.
7. The Quotation must be unconditional.
8. The Department will deduct Income Tax at source under relevant provisions of the Income Tax Act, 1961 from the bidder sum as Income Tax on the Income comprised therein or at the rate as prescribed by GOI from time to time.
