#### EXPRESSION OF INTEREST FOR STATE LEVEL EXPERT APPRAISAL COMMITTEE (SEAC) AND STATE LEVEL ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (SEIAA) -DELHI

Department of Environment, Govt. of NCT of Delhi invites Expression of Interest (EOI) for constitution of "State level Expert Appraisal Committee (SEAC) and State Level Environment Impact Assessment Authority (SEIAA) –Delhi" for Category B Projects as per EIA notification 2006 amended to 15-01-2019

#### I. Criteria for Experts for State Level Expert Appraisal Committee (SEAC)

The State Level Expert Appraisal Committee (SEAC) shall consist of only professionals and experts fulfilling the following eligibility criteria:

**Professional:** The person should have at least (i) 5 years of formal University training in the concerned discipline leading to a M.A./M.Sc. Degree, or (ii) in case of Engineering/Technology/ Architecture disciplines, 4 years formal training in a professional training courses together with prescribed practical training in the field leading to a B.Tech./B.E./B.Arch. Degree, or (iii) Other professional degrees (e.g. Law) involving a total of 5 years of formal University training and prescribed practical training, or (iv) Prescribed apprenticeship/article ship and pass examination conducted by the concern professional association (e.g. Chartered accountancy), or (v) a University degree, followed by 2 years of formal training in a University or Service academy (e.g. MBA/IAS/IFS). In selecting the individual professionals, experience gained by them in their respective fields will be taken note of.

**Expert:** A Professional fulfilling the above eligibility criteria with at least 15 years of relevant experience in the field, or with an advance degree (e.g. Ph.D.) in a concern field and at least 10 years of relevant experience.

**Age:** Below 70 years.

The Members of the EAC shall be experts with the requisite expertise and experience in the following fields/disciplines.

- **Environment Quality Expert:** Experts in measurement/ monitoring, analysis and interpretation of data in relation to environmental quality.
  - **Sectoral Experts in Project Management:** Experts in Project Management or Management of Process/Operations/Facilities in the relevant sectors.
  - **Environmental Impact Assessment Process Experts:** Experts in conducting and carrying out Environmental Impact Assessments (EIAs) and preparation of Environmental Management Plans (EMPs) and other management plans who have wide expertise and knowledge of predictive techniques and tools used in the EIA Process.
  - **Risk Assessment Experts**
  - **Life Science Expert in floral and faunal management**
  - **Forestry and Wildlife Experts**
  - **Environmental Economics Expert with experience in project appraisal**
- i. The Membership of the SEAC shall not exceed 15 (fifteen) regular Members.
  - ii. The Chairman shall be an expert in terms of the eligibility criteria given above in one of the specific fields, with sufficient experience in environmental policy or management.
  - iii. The maximum tenure of a Member, including Chairperson, shall be for 2 (two) terms of 3 (three) years each.

## **II. Criteria for Experts for State Level Environment Impact Assessment Authority:-**

- (1) A State Level Environment Impact Assessment Authority to comprise of three Members including a Chairman and a Member Secretary to be nominated by the State Government or the Union territory Administration concerned.
- (2) The two Members shall be either a professional or expert fulfilling the eligibility criteria as given under **I point**.
- (3) The Chairman shall be an expert in terms of the eligibility criteria given above in one of the specific fields, with sufficient experience in environmental policy or management.
- (4) One of the specified Members who is an expert in the Environmental Impact Assessment process shall be the Chairman of the SEIAA.
- (5) The non-official Member and the Chairman shall have a fixed term of three years (from the date of the publication of the notification by the Central Government constituting the authority).
