I am directed to say that the Appropriation (No.2) Act 2017 (Delhi Act 02 of 2017 as passed by the Legislative Assembly of National Capital Territory of Delhi on 10th March, 2017 has received the assent of the Hon'ble Lt. Governor, Delhi on 22nd March, 2017.

The Department of Law, Justice & Legislative Affairs has also requested General Administration Department, GNCT of Delhi for publishing that Delhi Appropriation (No.2) Act 2017 (Delhi Act 2 of 2017) Delhi Gazette (Part-IV)-Extra-Ordinary.

Funds as per Detailed Demands for Grants 2017-18 are available to the Departments for incurring expenditure subject to approval of Competent Authority. You are requested to depute an official to collect the approved Demands for Grants 2017-18 with relevant documents from Finance (Budget) Department on any working day. A copy of the approved Detailed Demands for Grants (2017-18) has also been uploaded on the website of Finance Department, Govt of NCT of Delhi. (www.finance.delhigovt.nic.in) for ready reference.

With the merger of Plan and Non-Plan classification of expenditure from 2017-18, the Budget Estimates 2017-18 contains Revenue and Capital classification only for incurring expenditure. Accordingly Detailed Demands for Grants contains classification of expenditure in respect of your department.

Provisions available under the object head "Office Expenses" are allocated into different items of expenditure. Department are requested to make internal allocation in such a way that sufficient funds are available during the entire financial year for payment of essential items e.g. electricity, water and telephone etc. Finance Department will not consider any requests for augmentation of provisions under Office Expenses simply on the ground that payments of essential & urgent items are pending.
